They are involved in the cultivation, processing, and supply of food production; in practice, they dramatically influence countries' economies, health, and prosperity.

Poverty is the result of unsuccessful past and ongoing failure actions. Obviously, "more of the same" is not the solution. Quite the opposite, "more of the same" fixes poverty as a way of life for future generations. Einstein said, "Insanity is doing the same thing over and over again and expecting different results." Hence, there is an urgent need for a CHANGE - a radical change - in the perception of farmers' poverty and the time frame.

This statement is well addressed by the UN SDGs and requires no further explanations. Such a move is complex and deserves to be led jointly by involved stakeholders, including governments, private and public organisations, NGOs, food processors, exporters and importers of agro-produce, consumers' organisations, and above all, by farmers.

Following are the criteria by which the conference management will select the projects that will be eligible to be presented:

- **Sustainable** on a business basis (even without external support).
- Increase in revenue in percentages and absolute numbers, per hectare/production unit.
- Potential global impact the scope and ability to apply to different crops, farmers, and countries.
- **Time** the pace of change /income growth as a function of time.
- **Persistence** the model/project should hold the ability to generate long-term and continuous income growth.
- In line with UN SDG.
- Creating economic abundance (as opposed to preventing hunger and poverty).





- Export project model with export potential products.
- Moving from agriculture to agro-industry a project leading to the industrialisation of the agro-sector and converting the scope of a hectare from a "food creation unit" to an income creating "business value unit."
- Accessible and affordable for smallholders.
- Creates impact at the national level jobs, the influx of foreign currency, increased tax payment, legacy, skills, know-how, etc.
